# Information and Procedures Concerning the Agenda and Board of Directors Meetings

#### Meeting Information:

Meetings are generally held the third Friday of each month. Meetings start at 3:00 p.m. and are held in the Eagle Lake Community Center, 502-907 Mahogany Way, Susanville. At the end of each year the Board adopts a meeting schedule for the upcoming year. Meeting dates can be changed as a result of holidays or other events so please check the meeting calendar to be certain. Copies of the adopted meeting calendar for the year are available in the District Office or on the District's website.

#### Agenda Information:

The agenda for every meeting of the Board is posted in front of the District Office at least 72 hours before each meeting (24 hours before a special meeting) and is also available on the District's website. A copy of the agenda and supporting materials provided to the Board of Directors members to explain each agenda item (excluding documents that are not a public record within the meaning of the Public Records Act) are available for your review at the District Office (please do not remove items from these files), and on the District website. Copies of supporting materials can be made for you at a charge to cover costs.

#### Agenda Format and Meeting Order:

The agenda is usually organized into the following areas and meetings generally proceed in the following order:

- Pledge of Allegiance.
- 2. Approval of Agenda.
- 3. General Manager Report to Board.
- 4. Fire Chief Report to Board.
- 5. <u>Public Comment</u>: this is the area of the agenda where members of the audience may address the Board on any matter not listed on the agenda. The Board, by law, cannot take action on any matter not listed on the agenda, but may respond to statements or questions and provide staff direction. Pursuant to Governor's Order N-29-20, public comments may be submitted via email to generalmanager@spaldingcsd.org or via telephone at 530-825-3258 at least two hours prior to the start of the meeting.
- 6. Approval of Minutes: this is the time for the board to approve the minutes from the previous board meeting.
- 7. <u>Consent Calendar</u>: these are items that are considered routine and are handled by one motion and vote of the Board. If you wish to discuss any item on the Consent Agenda you can either fill out a speaker card (located in the back of the board room) and give it to the Clerk of the Board (sitting to the left of the Board) or, when the Chair asks if there is anything anyone would like to remove from the Consent Agenda, stand and approach the podium and request the item be removed. The removed items are discussed at separately.
- 8. <u>Public Hearing and Timed Items</u>: this is where items that are required by law to be heard as a public hearing are set. This is the section where appeals before the Board are usually discussed. Hearings may start after the time listed, but will never start before the time listed.
- Board Members Reports / Committee Reports: this is where board members can speak on any conferences, workshops, meetings or other activities SCSD General Interest including AB1234 travel reports.
- 10. New Business: this is where presentations to the Board and items that require full discussion are heard.
- 11. Continuing Business: this is where staff and board can engage on business matters on-going or previously heard.
- 12. General Managers Report: this is where the GM informs the board on any current activity or situation occurring in the district.
- 13. <u>Closed Session</u>: The Board is authorized, by law, to meet in a closed session in certain circumstances. This area of the agenda identifies those items that will be discussed during the closed session.
- 14. <u>ADJOURNMENT</u>: this is the time that the board conclude the current meeting and sets the date, time and location for the following special or regular scheduled board meeting.

# **Public Participation:**

It is the policy of the Board of Directors, and a requirement of the California Open Meetings Law, to allow members of the public the opportunity to comment on all matters before the Board. Public participation is limited to matters within the subject matter jurisdiction of the Board pursuant to Government Code Section 54954.3. The Board has adopted policy and procedures to facilitate the meeting process and conduct.

The Board of Directors is committed to making its proceedings accessible to all citizens. Individuals with special needs should call the District Office at 530.825.3258, Tuesday through Friday, 9:30 a.m. to 3:30 p.m. to request disability-

SUBJECT: General Managers Report Board Meeting Update 2-19-21

#### SUMMARY:

The Spalding Volunteer Fire Department is beginning to receive some parts to their new updated aluminum flagpole. We are hoping to get the flagpole within the next few week and then begin to take steps for the final installation. This will be a gem for the District to have which will beautify and support a new flag to fly at the district soon.

The Spalding Volunteer Fire Department is also asking for your help to trim back any tree limbs and or brush that may be encroaching into your community roads. With our new larger Fire Equipment, it would very helpful to cut back these limbs and brush to provide easier accessibility to our residents in any emergency you may have on your residential streets. FEMA Road Grant Update: Board Meeting 2-19-21

I have discussed in previous Board Meetings that I would be formalizing the costs incurred for material and equipment that was used to repair a pot hole not listed on a very specific list supplied by FEMA. To arrive at these costs, I used an hourly rate for the equipment used as well as the material costs used to fill the pot hole.

- Material Cost were \$15.00 per yard x 5 yards for a sum of \$75.00.
- Motor Grader Rental \$43.79 per hour
- Bomag Roller Compactor Rental \$44.00 per hour
- Dump Truck Rental \$44.00 per hour
- Water Truck Rental- \$30.38 per hour

The total incurred cost for material and rental is \$237.17 for the pot hole error in question. I have shared this cost of the Districts findings with Ted Thomas to move forward with resolving this issue.

Ted Thomas Statement: Board Meeting 2-19-21

I have taken the costs summarized by Ken today for the material and equipment used for the error I made for filling a pot hole. I have written a check for amount of \$250.00 to the Spalding CSD to be placed back into the FEMA Road Grant account. I want to publicly apologize for my error that I made and by my repayment of these funds, this will finalize this issue regarding the FEMA Road Grant.
