**TERMS OF USE**

1) The Recreation Area Access Pass permits the access of one vehicle. Each vehicle must display its own pass. Said vehicle(s) must be listed on this application and the registered owner must be the applicant. Copy of the current registration for each vehicle must be submitted upon application. Each vehicle must be identified by MAKE, VEHICLE LICENSE NUMBER and STATE OF REGISTRATION.

2) Recreation area access will be obtained by the display of the window decal. The decal must be adhered to the inside, bottom right-hand corner of the front windshield (passenger side).

3) The Recreation Area Access Pass (decal) is the property of Spalding CDS Recreation Area. Applicant agrees that the decal issued to a designated vehicle will only be used in said vehicle. Applicant agrees that he/she will not loan, sell or in any way assign to any other vehicle or person. Applicant agrees to notify Spalding CSD Recreation if said vehicle is sold or otherwise disposed of by applicant. Applicant must provide Spalding CSD Recreation with the original window decal to be eligible for a replacement.

4) Applicant hereby agrees that the designated vehicle will be parked in a marked parking area or in other such designated zones in the recreation area. Vehicles parked illegally or in such a way as to impede traffic or any vehicle left unattended on the boat launch ramp may be towed at the owner's expense.

5) Applicant hereby agrees that if conditions set forth above are violated, the Recreation Area Access Pass will immediately be surrendered upon demand by Spalding CSD Recreation without refund. Applicant understands and agrees that Spalding CSD Recreation may refuse to issue further passes to persons from whom pass use has been revoked. Policy prohibits discrimination because of race, color, national origin, gender, religion, or handicapping condition.
