I am writing this letter regarding several issues that I would like you to address.

- #1) I submitted a letter to you regarding Ted Thomas and his fiduciary responsibility to the FEMA Grant that he was responsible for overseeing on the road project last fall of 2019. He used some of the materials to fix a road that was not within the scope of the project and he told several people he would reimburse the FEMA funds for the cost of these materials. He has not done this to my knowledge. I would like to know the status of this issue.
- #2) I would like to address several issues about the Board and its handling of concerns within the Spalding Community.
 - a) Failure to follow the Brown Act during meetings. (See attachment regarding Brown Act)
 - a. One of those failures is not allowing people to comment during the period of time allotted for this very thing. It is stated in the Agenda itself that the public has the right to comment, but that was not allowed at the last meeting I attended. This type of behavior during a public meeting does not reflect well on the Board as a whole. The intent of the Board meetings is to allow people to be able to bring their concerns forward and to have the Board listen and give direction on next steps regarding these concerns. That is not something that I have experienced with this Board in the past and currently. I have brought forth issues regarding the Cattle in this Community and the destruction it has done to Eagle Lake. I feel like it has fallen on deaf ears and that Board members don't care about this issue. This issue impacts everyone in this community as well as the public who use the facilities in this Community. It impacts their Health, Safety, and the Recreation around the Lake.
 - b. When the Board "has an open session then is followed by a closed session, the Board must report on final action taken in closed session under specified circumstances. Where final action is taken with respect to contracts, settlement agreements and other specified records, the public may receive copies of such records upon request." (This is taken directly from the Brown Act.) I have observed that this procedure has not been followed and am concerned that the Board is not following proper procedures.
 - b) The Board has failed to meet the conditions set in the Lassen LAFCO dated, March 14, 2011 or the Resolution 2011-0009. The LAFCO is extremely specific in the care

that is be done for the Marina and Picnic Area by the Marina. It was intended to be a place that people could use and recreate in a pleasant manner. This has not been the case in the last several years as cattle have been entering this area as well as into the Community and the Airstrip. Many residents complained and a few took action themselves to help get the cattle away from the areas being impacted. This was brought to the attention of the Board, but no action or resolution was taken; at least there was nothing made public.

c) Board members are elected to represent the Community as a whole. It is incumbent upon each Board member to ensure that the people they represent are heard and that actions are taken as appropriate; regardless of whether they agree or disagree on a personal level. I, as a resident of this Community, feel that the Board only put what they want to discuss on the Agendas and ignore other items brought to their attention, especially if it is too controversial to discuss.

In closing, I would like to see some changes in the way the Board handles the issues brought forth, as well as treating the public with respect and allowing them to voice their opinions, whether any one of you agree or disagree. I would like to see these issues discussed and then either a resolution or next steps put into place.
