 - A. SCSD Auditor 2021 Audit Proposal from Larry Bain, CPA (recommended by Robert W. Johnson CPA Group) for 2021 audit.

Recommendation:

It is my recommendation that the Board approve the appointment of Larry Bain, CPA as the SCSD Auditor for the 2021 Budget year.

Discussion:

Robert Johnson has been the SCSD auditor the four years prior to 2020-2021 fiscal year. He passed away in 2021 after completing the 19-20 fiscal year audit. There was no notification that Robert Johnson's company was not going to continue doing the SCSD audits for 2020-2021, and when we found out in June 2021 that this was the case, we had no success in finding an auditor who was willing to come audit that year.

In the meantime, the State of CA informed us that since each local agency is to submit financial transactions within seven months after the close of the fiscal year, and we did not complete that requirement, this failure to file the report could result in a fine ranging from \$1,000 - \$5,000 based on your prior year revenue.

Financial Consideration:

The fee for these services including out-of-pocket costs (such as report reproduction, word processing, postage, travel, copies, telephone, etc.) will not exceed \$6,900. This amount is less than originally charged by Robert Johnson, CPA (\$8,000) and less than the second proposal by Michael Knott CPA (\$10,000).

Results:

Getting the 2021 Fiscal Year Audit completed as soon as possible will stop the State of CA from any fines they may currently be required to implement.
