

RESOLUTION NO. 2026-03

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE
SPALDING COMMUNITY SERVICES DISTRICT
ORDERING AN ELECTION, REQUESTING THE LASSEN COUNTY
ELECTIONS OFFICIAL TO CONDUCT THE ELECTION, AND
REQUESTING CONSOLIDATION OF THE ELECTION

WHEREAS, pursuant to Elections Code Section 10002, the governing body of any district may, by resolution, request the Board of Supervisors of the County to permit the County Elections Official to render specified services relating to the conduct of an election; and

WHEREAS, the resolution of the governing body of the district shall specify the services requested; and

WHEREAS, pursuant to Elections Code Section 10002, the District shall reimburse the County in full for services performed upon presentation of a bill by the County; and

WHEREAS, pursuant to Elections Code Sections 10400, 10401, and 10403, whenever two or more elections are called to be held on the same day and in the same territory, or in territory that is in part the same, the elections may be consolidated upon order of the appropriate governing body; and

WHEREAS, a statewide General Election will be held on November 3, 2026, and it is desirable that the election for members of the Board of Directors of the Spalding Community Services District be consolidated with said election; and

WHEREAS, the terms of office for Directors Kathy Claytor and Ellen Stallings expire in December 2026, and one current vacancy exists on the Board of Directors;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Spalding Community Services District as follows:

SECTION 1. Election Called

The Board of Directors hereby calls for an election to be held on November 3, 2026, for the purpose of electing members to the Board of Directors of the Spalding Community Services District.

SECTION 2. Consolidation Requested

The Board of Directors hereby requests that the Board of Supervisors of Lassen County consolidate this District election with the November 3, 2026, statewide General Election pursuant to Elections Code Sections 10400, 10401, and 10403.

SECTION 3. Election Services Requested

The Board of Directors hereby requests that the Lassen County Elections Official conduct the election and provide all services necessary for the conduct of the election.

SECTION 4. Reimbursement of Costs

The District agrees to reimburse Lassen County for all costs associated with conducting the election upon presentation of a bill by the County.

SECTION 5. Offices to be Filled

The following offices shall appear on the November 3, 2026 ballot:

- Three (3) Full-Term Seats

- Kathy Claytor
- Ellen Stallings
- Current vacant position on the Board of Directors

*Subject to review and confirmation by the Lassen County Elections Official regarding the appropriate term length and ballot designation for the vacant seat.

SECTION 6. Filing of Resolution

The General Manager is hereby authorized and directed to file a certified copy of this Resolution with the Lassen County Board of Supervisors and the Lassen County Elections Official.
